Ordinance 98-9374 designated these street ends as view corridors but failed to incorporate this into the Blaine Municipal Code.

ORDINANCE NO 06-2633

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF BLAINE, WASHINGTON,  
AMENDING SECTION 12.16.060 TO INCLUDE STREET ENDS WEST OF PEACE PORTAL  
BETWEEN G STREET AND CHERRY STREET AS PERMANENT PUBLIC ACCESS RESERVES  
TO PRESERVE VIEWS

**Whereas**, On June 30, 1993 the City Council approved the Blaine Urban Waterfront Development Plan, which designated the street ends of G Street, H Street, Martins Street, Clark Street, Boblett Street and Cherry Street as “viewpoint parks”; and,

**Whereas**, on June 3, 1998 the City Council approved Ordinance 98-2374 mandating that the street ends of G Street, H Street, Martin Street, Clark Street, Boblett Street and Cherry Street lying west of Peace Portal Drive be maintained as public access and view corridor reserves; and,

**Whereas** the City of Blaine Comprehensive Plan (1999) policy statement 4.5 in Chapter 7 states, “Street ends west of Peace Portal Drive should be maintained as public view corridors and developed as parklets when funding allows”; and,

**Whereas**, the City of Blaine Comprehensive Parks Plan, approved in October of 2004, identifies these road end parks as critical view and public access parks; and

**Whereas**, it is in the best interest of the City to have Ordinance 98-2374 added to the Blaine Municipal Code,

NOW, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BLAINE AS FOLLOWS:

**SECTION 1:** Blaine Municipal Code Section 12.16.060 is hereby is amended to read as follows:

**12.16.60 Criteria for council decision.**

A. The city council shall not vacate any street, alley or parts thereof if any portion thereof abuts any body of salt or fresh water unless the vacation is sought to enable the city or state to acquire the property for port purposes, boat moorage, or launching sites, park, viewpoint, recreational or educational purposes or other public uses.

**B. The street ends of G Street, H Street, Martin Street, Clark Street, Boblett Street and Cherry Street lying west of Peace Portal Drive shall be maintained from this day forward as public access and view corridor reserves.**

C. The city shall not vacate any previously dedicated right-of-way unless, upon all the facts presented in public hearing, it concludes that:

1. Granting the vacation will not conflict with the general purpose and objectives of the city’s comprehensive plans for land use, transportation, utilities, drainage, parks, trails and open space; and
2. The vacation will provide a public benefit or be for a public purpose; and
3. Vacation of the right-of-way will not adversely affect the street pattern or circulation of the immediate area or the community as a whole; and
4. The right-of-way to be vacated is not contemplated or needed for future public use; and

49           5. There is at least one alternate mode of ingress and egress meeting city standards for  
50 emergency services available to all abutting owners, even if less convenient than the existing right-  
51 of-way; and

52           6. Provision has been made for utility easements where needed for the right to construct, repair  
53 and maintain public utilities and services; and

54           7. The request for vacation was not initiated to correct a condition created by the applicant in  
55 violation of city ordinance; and

56           8. The vacation will maintain or create straight and continuous right-of-way lines on at least  
57 one side for the full block.

59 **SECTION 2:** Should any section, clause or provision of this ordinance be declared by the courts to be  
60 invalid or unconstitutional, the same shall not affect the validity of the ordinance as a whole or any part  
61 thereof, other than the part of the ordinance declared to be invalid.

63 **SECTION 3:** This Ordinance shall take effect and be in force from and after its passage by the City  
64 Council and approval by the Mayor, if approved, otherwise, as provided by law and five days after the  
65 date of posting for publication.
