A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BLAINE,
WASHINGTON WAIVING THE BID REQUIREMENTS AND ALLOWING A SOLE
SOURCE FOR SUPPLY AND SERVICE OF SENSUS METERS AND SENSUS'
DISTRIBUTOR FOR THE CITY'S UTILITIES

WHEREAS, the City of Blaine is required to follow the competitive bid requirements of the State of Washington, and

WHEREAS, RCW 39.04.280 allows the City Council to waive the competitive bid requirements when purchases are clearly and legitimately limited to a single source of supply, and

WHEREAS, the City Utilities use a billing and metering system that uses Sensus meters exclusively, and

WHEREAS, the Sensus meters are limited to one distributor,

THEREFORE, BE IT RESOLVED that the City Council of the City of Blaine, Washington, recognizes there exists a sole source for supply and service of Sensus meters, and waives the competitive bid requirements for these meters.
