WHEREAS, the City Council may determine that these items are surplus property; and

WHEREAS, the Revised Code of Washington (RCW) 39.33.010 “Sale, exchange, transfer, lease of public property authorized,” permits any political subdivision of the State of Washington to dispose of any real or personal property to any political subdivision thereof, on such terms and conditions as may be mutually agreed upon by the proper authorities of the state and/or the subdivisions concerned; and

WHEREAS, the City of Blaine has been annexed into and is part of Fire District 13; and

WHEREAS, it is in the best interest of the Citizens of Blaine to transfer these Fire vehicles to Fire District 13,

THEREFORE, BE IT RESOLVED that the City Council of the City of Blaine, Washington surpluses and transfers the following Fire vehicles to Fire District 13:
