Bids were opened at Public Works on March 16, 2006 at 2:00 pm for a 1500 kVA three-phase pad mounted transformer. Three bidders responded with prices for four different transformers as shown in attachment A. The lowest bid was for an ABB transformer supplied by WESCO. The ABB transformer meets or exceeds all the technical specifications provided by the City.
