**ANALYSIS/SUMMARY:**

The initial design contract analyzed various stormwater problems within the City including those along Drayton Harbor Road and Semiahmoo Parkway. We have identified a series of engineering solutions and this amendment provide for the first phase. It addresses critical improvements to stormwater conveyance along Semiahmoo Parkway from Mallard Loop to the current Drayton Harbor outfall across from the existing wastewater treatment plant. The initial analysis indicated that properly sized piping will allow portions of the existing steep ditch to be converted to a pedestrian walkway which is sorely needed in this area. This expanded engineering effort includes survey, alternative analysis, final design, and preparation of bid package for the construction of the stormwater facilities with a pedestrian walkway over a portion thereof.

Authorize the City Manager to sign Amendment #6 to professional services agreement (S04-07) with Reichardt & Ebe Engineering, Inc., not to exceed **\$23,000** without further City approval.

CONTRACT AMENDMENT #6  
to  
PROFESSIONAL SERVICES AGREEMENT S04-07  
with Reichhardt and Ebe Engineering, Inc. for  
Multiple Stormwater Project Design

The contract between the City of Blaine and Reichhardt and Ebe Engineering, Inc. for engineering design and construction support services effective through December 31, 2006 is hereby amended as follows:

**Item #1:**        **Section 1, Scope of Work:** The original contract is amended to increase the scope of task one, the Semiahmoo Development Drainage Improvements, to include Final Design of Outfall & Pedestrian Walkways as follows:

As has been discussed with the City staff, it is essential that the issues with drainage in this area be resolved starting at the downstream end. This will ensure that sufficient capacity exists to convey stormwater as the problems are resolved. Therefore, this amendment shall act to re-allocate the remaining funds in the previous amendment for this project to those portions downstream. In addition, this amendment will expand the scope of work to include survey, alternative analysis, final design, and preparation of bid package for the completion of pedestrian facilities and an outfall to Drayton Harbor between Mallard Loop and the Waste Water Treatment plant.

**Item #2:**        **Section 2, Term:** The contract term remain unchanged.

**Item #3:**        **Section 3, Compensation:** shall be amended as follows:

“The City shall pay the Consultant on a time-and-expenses basis **Twenty Three Thousand Dollars and No Cents (\$23,000.00)** for additional consulting engineering services as described above, for a new revised total contract amount not to exceed **\$131,918.00**, without prior approval.”

All work shall comply with City standards and shall be approved by the City prior to payment.

All other items, terms and conditions of the contract remain unchanged.
