ANALYSIS/SUMMARY:

- Change Order No. 6 to the Downtown Boardwalk (Phase 1) Construction Project Contract will:
 - Add a pedestal for the new Vigil Sculpture at the H Street Plaza (\$6,576.02 w/o tax), and
 - Change the stamped concrete sidewalk area at the H Street plaza to new engravable paver bricks (\$6,238.06 w/o tax).
- Change Order No 7 to the Downtown Boardwalk (Phase 1) Construction Project Contract will
 - Remove the remaining original paver bricks from the G Street plaza sidewalk area (\$1,069.98 w/o tax), and
 - Change the stamped concrete and original paver brick sidewalk areas at the G Street plaza to new engravable paver bricks (\$13,008.73 w/o tax).

In order to accommodate these two changes, the contract term is extended thirty six (36) calendar days, resulting in a revised Substantial Completion Date of June 26, 2006.

RECOMMENDATION: Waive 2nd Reading: Staff recommends that City Council authorize the City Manager to execute Change Orders Nos. 6 and 7 for a pedestal for the Vigil Sculpture and replacement of stamped concrete sidewalk areas with engravable paver bricks at the entrances to the G and H Street plazas.

FISCAL ANALYSIS:

Whatcom County EDI Grant and Loan package and Capital Facilities Fund 308 (real estate excise tax) is the funding source for both Change Orders. For Change Order No. 6, the Vigil Sculpture Donation Fund will reimburse the new pedestal funding source, and the Paver Bricks Donation Fund will reimburse the new engravable paver bricks funding source.






