**ANALYSIS / SUMMARY:** The contractor has incurred extra costs resulting from unforeseen conditions of a significant number of additional pilings that needed to be removed while excavating for the equalization storage tank. The prices in contract specification were used as the basis for determining a fair and equitable adjustment to the contractor to cover the contractor cost for removal of these items.

The contractor proposed a cost savings to the City by removing the light-weight concrete fill under portions of the roadway and replacing it with less expensive geotextile material to maintain sufficient strength in the roadbase.

**RECOMMENDATION:** ; Waive 2<sup>nd</sup> Reading: (Including conditions of approval if applicable) Staff recommends that City Council authorize the City Manager to execute a construction change order in the amount of \$65,308.06 which includes adding \$178,596 to Schedule B Wastewater Equalization Storage and deducting \$128,290 from Schedule A Roadway.

- 1) Removal of additional wood piles, pile caps, and planking in addition to the contract specification description for Bid Item 5, "Removal of Buried Structures and Obstructions"
- 2) Replace Bid Item 34, "Light Weight Concrete Fill" with 2100 square yards of Bid Item 7, "Subgrade Repair"

The agreement as stated above is subject to the following conditions:

- 1. The Contractor agrees to complete the work in accordance with the project specifications and a September 8, 2006, letter from Hugh Davis, Colacurcio Brothers to Scott Rzemien, R&E.

The cost shown below shall be full compensation for the items as indicated in summary above and shall be considered full payment for all materials, labor and equipment for the work.
