ATTACHMENTS: Resolution 1445-06; revising the Unified Fee Schedule to establish new wastewater monthly rates and connection fees for 2007.

ANALYSIS / SUMMARY: The attached resolution adopts the recommendations of the FCS Group, the City's wastewater rate consultant, based on their annual review of the wastewater utility and the capital improvement program for replacing the City's treatment facilities. Their recommendations, provided in an October 2, 2006 work session, were to increase the wastewater monthly fees by 6.52% and the connection fees to \$5316 per equivalent residential unit (ERU). This resolution incorporates these 2007 rates and fees into the City's Unified Fee Schedule, previously adopted by Resolution 1436-06.

Staff recommends that Council adopt Resolution 1445-06 amending the Unified Fee Schedule to include increases in wastewater monthly user fees and connection charges for 2007.

FISCAL ANALYSIS: The increase in wastewater fees and connection charges is required to financially support the Wastewater Capital Improvement Program including a new Water Reclamation Facility. The utility revenue based on these increases is projected to cover the estimated program costs including debt service on loans for design and construction of these improvements.
