ANALYSIS / SUMMARY: During Neighborhood Watch meetings sponsored by the Public Safety Department, residents of Harvey Road north of H Street commented on difficulties they encountered getting goods and services to their homes because of the misalignment of Harvey (this portion of the road is west of the southerly portion of Harvey Road). They requested that Harvey north of H Street be designated North Harvey Road, and that their addresses be changed accordingly. The change has already been coordinated with the U.S. Post Office and emergency services providers, with consensus that this is appropriate. Adoption of the ordinance is a statutory formality required to effect the change.

ORDINANCE NO. 07-2681

**AN ORDINANCE OF THE CITY COUNCIL OF THE
CITY OF BLAINE, WASHINGTON, AMENDING
BLAINE MUNICIPAL CODE SECTION 12.08.020
TO ADD A NEW SECTION Q. RENAMING HARVEY ROAD
NORTH OF H STREET AS “NORTH HARVEY ROAD”.**

**BE IT HEREBY ORDAINED BY THE CITY COUNCIL OF THE CITY OF
BLAINE as follows:**

SECTION 1: Blaine Municipal Code Section 12.08.020 is hereby amended by the addition of item Q to read as follows:

12.08.20 **Established.** The names for the streets and public ways listed below are changed as follows:

SECTION 2: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION 3: If any section, subsection, clause or phrase of this ordinance is for any reason held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining portions of this Ordinance.

SECTION 4: Effective Date. This ordinance shall be in full force and effect upon approval.
